

Undergraduate Scholarship Program

Utility Pipeline Ltd, (UPL) intends to award at least three \$1,500.00 scholarship(s), to qualified applicants. The general terms and conditions for qualified applicants are as follows:

1. Applicant, applicant's legal guardians, parent or grandparent, or graduating high school must be a member of an affiliated natural gas cooperative or natural gas utility in Ohio, Pennsylvania, Indiana, Virginia, and West Virginia managed by Utility Pipeline Ltd.
2. The applicant must be a graduating high school senior attending a United States accredited 4-year college or university in the fall of 2025 (12 credit hours or more). Once an applicant wins the award, they are ineligible to apply for future awards.
3. Minimum **3.0 cumulative** high school GPA.
4. The applicant's eligibility will be based on the application materials, academic performance, community service and promise shown for future achievement, based on the judgment of a review panel.
5. The award will be applied towards school tuition and is paid directly to the college or university.
6. The applicant must submit a completed legible application form along with a **typed** one-page narrative on one of the following topics: (handwritten and/or incomplete narratives will not be processed)
 - a. How do you feel advancements in the natural gas industry have influenced your local economy? (Positively or Negatively)
 - b. Tell us why you are striving to work in the natural gas industry in the future.
 - c. Name three products other than gasoline, lubricants and tires that are made from petroleum. How would your personal life be different without these products?
7. **Each application must be accompanied by:**
 - a. One letter of recommendation - academic or one non-family member.
 - b. Proof of acceptance to college or university(s) (class schedule, receipt for tuition, letter from institution acceptable)
 - c. Sealed transcript
8. **Applications and related materials must be received no later than March 28, 2025. Applications postmarked after March 28, 2025 will not be accepted.** (Incomplete applications will not be considered.)
